SELECTED FOR LEWIS COUNTY LEGAL PRINTING  
FOR JULY 1, 2025, THROUGH JUNE 30, 2026

**WHEREAS**, the Lewis County Board of County Commissioners (BOCC) issued a call for sealed bids for the printing of legal publications on February 4, 2025; and

**WHEREAS**, the county received three bids; and

**WHEREAS**, bids from The Chronicle, The East County Journal and The Lewis County News were opened during an open public meeting on March 18, 2025; and

**WHEREAS**, the bids submitted were as follows:

\*The Lewis County News submitted a bid for 7.5-point type; and

**WHEREAS**, The Chronicle is the lowest qualified bidder per the bid specifications; and

**WHEREAS**, per RCW 36.72.075, the county legislative authority must -- at its first meeting in April -- select a newspaper to serve as the official county newspaper for one year beginning on the first day of July.

**NOW THEREFORE BE IT RESOLVED** by the BOCC (1) that The Chronicle be named Lewis County's legal newspaper of record for the period beginning July 1, 2025, and ending June 30, 2026, at a cost of \$3.80 per 1.20 column inch at 8-point type in conformance with the sample furnished with The Chronicle's bid and (2) that the County Manager be authorized to sign the Printing Contract with The Chronicle.
