• Master Contract No. 01114, executed as a Participating Addendum to a competitively awarded NASPO ValuePoint Data Communications Master Agreement.

• Master Contract 01114 Master Agreement AR233 (14-19), which was originally scheduled to expire May 31, 2020, has been extended through May 31, 2021 with Cisco Systems Inc., Juniper Networks, Avaya, F5 Networks, Mitel Networks, Inc., Ciena Communications, Inc. and Extreme Networks, Inc. Customers may continue to purchase, through their authorized partners/resellers with these manufactures, through May 31, 2021.

DES has established new participating addenda's (New contract 05819) with Hewlett-Packard Enterprise Company (HPE) and Palo Alto Networks, Inc. effective June 1, 2020. Information regarding this contract will be available on DES's website in the coming weeks. DES is working to establish participating addenda's with Cisco, Juniper, and potentially Cradlepoint.

Note to customers: Avaya and F5 are not among the vendors on the new contract 05819. After May 31, 2021, customers will need to find alternative measures to procure from these manufactures.
