In the matter of the vacation of a portion of Mountain View Drive, Lewis County, Washington, the Board finds as follows:

FIRST: That on the 15th day of December, 2014, in regular session, the Board of County Commissioners, duly passed Resolution 14-332 entered upon their minutes declaring their intention to proceed to determine whether or not that certain portion of road in Lewis County named and designated as Mountain View Drive should be vacated and abandoned, and ordered and directed the County Engineer to make an examination of Mountain View Drive.

SECOND: That Mountain View Drive right of way does not directly abut a body of water.

THIRD: That on the 22nd day of April, 2015, the County Road Engineer filed his report in writing with the Board setting forth all things required by law to be set forth in the engineers report.

FOURTH: That the Board by order duly passed on the 4th day of May, 2015, fixed the 1st day of June, 2015, at or after the hour of 10:00 A.M., in the Commissioners Hearing Room on the 2nd Floor of the Historic Courthouse, Chehalis, Lewis County, Washington, as the time and place for the hearing on the report of the County Engineer,

and that the Board duly caused notice thereof to be published and posted as required by law, and the Board now finds there to have been compliance with all legal requirements.

FIFTH: And that on the 1st day of June, 2015, the vacation of a portion of Mountain View Drive came regularly on for hearing, and due proof having been made to the satisfaction of the Board by affidavit of the publication and posting of the notices of hearing, and the Board having considered the engineers report and all evidence relative to such vacation, now here finds this portion of Mountain View Drive not to be a public necessity.

NOW, THEREFORE, IT IS ORDERED by the Board that all provisions of RCW 36.87 and LCC 12.15 have been met and a portion Mountain View Drive be and is hereby vacated as follows:

All that part of Mountain View Drive dedicated to the public in the Plat of Eighth High Valley Park, recorded in Volume 5 of Plats, Pages 67-69, records of Lewis County, lying West of Cowlitz View Drive and East of Cannon Road, in Section 1, Township 13 North, Range 9 East, W.M.
